

# 2017 Delta County Fair Demolition Derby

## OFFICIAL ATV BARREL CHALLENGE RULES



**NOTHING OTHER THAN WHAT IS SPECIFIED IN THESE RULES IS ALLOWED.  
ALL RULES MUST BE FOLLOWED OR YOU WILL NOT RUN.**

**All Judges decisions are FINAL.**

### A. GENERAL RULES

1. Contact Demolition Derby Superintendents Kristi St. Clair (970-201-8946) or Chance Fisher (970-835-3399) with any questions you have. If these rules or a phone call to a superintendent doesn't say you can do something, THEN DON'T. We can't stress enough to call first. 2. **All ATV riders must attend the driver's meeting.**
3. ATV's cannot be ridden outside of the Arena and pits. No hot rodding in the pits! Maximum of 5 mph. This will be the quickest way to be DISQUALIFIED.
4. **No riders are allowed to consume alcohol - period. If you are wearing a rider's wristband and observed drinking ANY form of Alcohol, YOU WILL BE DISQUALIFIED. The Fair Board reserves the right to contact law enforcement to enforce this rule and eject riders/teams from the fairgrounds.**
5. **INSPECTIONS: ALL TEAMS MUST BE AT THE ARENA BY 3 PM. PITS WILL OPEN AT NOON.**
6. Operators must stay on their machine during the run; dismounting from the machine terminates the run, unless otherwise instructed in the event description.
7. Only one rider may be on a machine during the course run. No passengers will be allowed.
8. In case of a breakdown, rider is responsible for hooking the towrope to his/her machine; any and all damages incurred when being towed are the sole responsibility of the rider.
9. The Delta County Fair Board and Demolition Derby Superintendents reserve the right to rework the course or heats at any time.

### B. ATVs ALLOWED/PROHIBITED

1. Stock and modified Sport and Utility ATV and side-by-side machines with any tire size are allowed.
  - a. Naturally aspirated motors only.
  - b. 2WD and 4WD machines are allowed, but 4WD must be disabled during the course run.
2. The following are prohibited:
  - a. Paddles, chains and spikes.
  - b. Nitrous oxide and nitro methane.
3. ATVs may be inspected at any time and at the discretion of the Superintendents.

### C. MINIMUM AGE OF RIDERS/LIABILITY WAIVER

1. ATV riders participating in the ATV Barrel Challenge at the Delta County Fair must be at least **16** years old as of August 1, 2017. Riders under the age of 18 years of age must have a parent/legal guardian sign the liability waiver in addition to the rider.
2. All participants are required to sign a liability waiver. Once the liability waver has been signed, participants will receive a wristband. Participants must have a wristband to remain in the pit area or to compete.

**D. MINIMUM SAFETY GEAR REQUIRED**

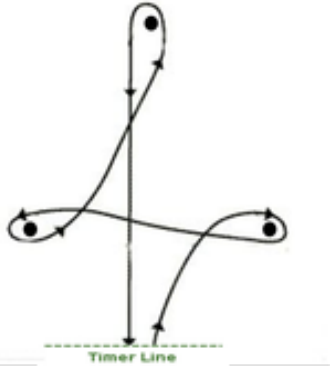
- 1. Any rider competing and/or operating an ATV on the fairgrounds is required to wear a D.O.T. approved helmet (helmet must be worn at all times while operating an ATV), eye protection (glasses, goggles, face shield), long-sleeved shirt, long pants and closed-toed shoes. Other protective gear is strongly recommended. The Delta County Fair Board will NOT provide this safety equipment.

**E. ATV BARREL CHALLENGE STRUCTURE**

- 1. The ATV Barrel Challenge will take place on Saturday, August 5, 2017 during the Demolition Derby. ATV Barrel Challenge heats will run between classes as determined by the Demolition Derby Superintendents. Classes & heats will be structured based upon the number of entries received prior to the event and will be posted at least one (1) hour prior to the start of the demolition derby.
- 2. **Registration will take place via the official entry form on [DeltaCountyFair.com](http://DeltaCountyFair.com). Entries will close on August 1, 2017 at midnight.**
- 3. Participants may enter more than one class, and enter multiple ATV/UTVs but may enter each class only once.
- 4. ATV's may be used by more than one rider.
- 5. The following events may be run and/or counted for prizes.

**a. Barrel Race**

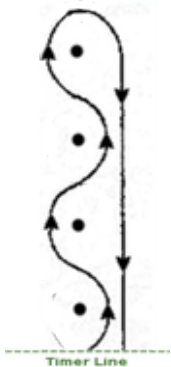
- i. The fastest time running the designated pattern around the barrels. The pattern may be run in either direction. Each barrel knocked over will result in a 5 second penalty. Breaking the pattern will result in disqualification.

**b. Pole Bending**

- i. The fastest time running the designated pattern. The pattern may be run in either direction. Each pole knocked over will result in a 5 second penalty. Breaking the pattern will result in disqualification.

## **F. DIVISIONS & CLASSES**

1. The following Divisions may be entered:
  - a. **ATV - Sport** (i.e. Polaris Scrambler, Can-Am Renegade)
  - b. **ATV- Recreation** (i.e. Polaris Sportsman, Kawasaki Brute Force, Honda Rancher)
  - c. **ATV - Utility** (i.e. Dump Bed/6x6)
  - d. **Side-By-Side - Sport** (i.e. - CanAm, Arctic Cat, Polaris RZR)
  - e. **Side-By-Side - Utility** (i.e. - Ranger, Gator, Kubota)
2. The following Classes may be entered:
  - a. 400-499 cc
  - b. 500-599 cc
  - c. 600-699 cc
  - d. 700-799 cc
  - e. 800-899 cc
  - f. 900-999 cc
  - g. 1000-1100 cc
  - h. 1000-1100 cc UTILITY UTV
3. The fair board superintendents will break classes down into equal sized heats based upon entries received.

## **G. PRIZES**

1. Award payouts will be awarded based on the fastest combined times of both the Barrel Race AND Pole Bending. Riders must compete in BOTH events to qualify for prize money payout.
2. Prizes will be paid to 1<sup>st</sup> Place in each class. Prizes will be calculated by the Superintendents.

The Delta County Fair Board, Superintendents, Committee and its representatives are not responsible for accidents, injury or theft to property. Personal ATV insurance and registration is highly recommended. Noncompliance with the rules of this event may result in disqualification, expulsion and forfeiture of all prizes.
